Sensitive Information

Where it is considered that disclosure of details of an interest could lead to violence or intimidation, and the Monitoring Officer agrees, any published version of the Register of Members' Interests will exclude details of the interest but may state that there is an interest, the details of which are withheld.

Notification of Interests

I recognise that to omit information, which ought to be given within prescribed time limits in this notice or to provide information, which is materially false or misleading, is a breach of the Local Code of Conduct and, in respect of Disclosable Pecuniary Interests, can be a criminal offence.

I also recognise that failing to give further notices in writing to the Monitoring Officer within 28 days of becoming aware of any change in order to bring up to date information given in this notice, or in order to declare an interest, which has to be declared, and which are acquired after the date of this notice is also a breach of the Local Code of Conduct.
