- (ii) Members referred to initial draft budget for 2023/24, prepared by the Responsible Finance Officer and noted the Council’s current contract for electricity was fixed until 2024 so the forecast was likely to be correct, although the fixed prices did not include possible increases in standing charges. OS2202.9 PLAY AREAS

Members referred to the report and were understanding of the request for the installation of goal posts, following results of a consultation held at the Emergency Services Day, held on 10th August 2022. They considered the two options and agreed Option A was too expensive and the design not suitable for the surrounding environment. Members were also not supportive of installing nets, as this would require a resource that wasn't currently available to install and remove. However, on referring to the results of the consultation, it was

RESOLVED	To approve Option B for the installation of goal posts, at a cost of up to £1500 to include installation.
